## **Drugs Conspiracy**

**Operation Zambia** – Multi handed Class A drugs conspiracy (Involving issues surrounding extensive covert surveillance and cell site )

## **Public disorder**

**Operation Reedham** – Conspiracy to commit Violent disorder. Only defendant of 13 to be acquitted following football related violent disorder in which the victim sustained horrific injuries.

## **Other**

**R v McG & Others** – [Matthew Bagnall](#), leading [Sasha Bailey](#), secure the acquittal of “McG” the lead defendant in the first modern prosecution of the Hijacking of an ocean going ship, following an eight week trial at the Central Criminal Court, prosecuted by T. Badenoch QC.

Successfully defended client accused of conspiracy to convert criminal property by the acquisition of stolen car parts for international exportation on an industrial scale – the value of those parts stretching into many millions of pounds.

## **Criminal prosecution**

**Murder** – secured a conviction whereby the defendant wasn't present at the scene but encouraged his nephew to beat the victim to death over the telephone following years of grooming of the nephew. Led by RCKC.

## **Fraud & Financial Crime**

Successfully defended a company director facing prosecution in one of the largest ever Trading Standards prosecutions for conspiracy to defraud. The defendant was a director of multiple companies, concerned in the manufacture, sale and distribution of products in the domestic heating market, with a turnover of over £46.7 million.

**R v H** – Defence multi handed ‘boiler house’ fraud involving sale of ‘fine wine’ investments.
